

Virtual Clinical Supervision Training

April 17-18, 2021 and April 24-25, 2021

Course Overview

The full training (all 4 sessions) will provide the participant with 12 hours of education in supervision methods, models and techniques, roles and responsibilities of a clinical supervisor, techniques specific to supervising counselors in the tasks of diagnosis, treatment planning and providing treatment and evaluation of supervisees in their work of assessment, treatment planning and providing treatment. This training will also cover the ethical guidelines and legal requirements for supervisors, using the 2014 Code of Ethics from the American Counseling Association and the most recent Arizona Board of Behavioral Health Examiners statutes and rules.

The supervision renewal training (April 24-25) will provide the participant with 6 hours of education reviewing supervision methods, models and techniques, roles and responsibilities of the supervisor and provide opportunity to practice in providing feedback and evaluation to supervisees in their work.

Course Objectives

- Participants will learn clinical supervision methods, models and techniques.
- Participants will learn roles and responsibilities of the clinical supervisor.
- Participants will practice providing feedback to supervisees using case scenarios.
- Participants will learn skills to oversee and evaluate supervisees in their work assessing, diagnosing, creating treatment plans and providing treatment.
- Participants will learn ethical guidelines and legal requirements for supervisors.
